

# MGTS IDAD Future Wealth Fund

## Factsheet – 01 January 2026



### Investment Objective

The objective of the MGTS IDAD Future Wealth Sub-fund is to provide capital growth over any 7 year period.

### Investment Manager Commentary

December was a challenging month for the IDAD Future Wealth Fund, with the portfolio returning -3.38%, compared with a +0.36% gain for the IA Flexible Investment sector. The decline reflected a broad pullback across growth-oriented and thematic equities, particularly those linked to technology, clean energy and China-related exposures, as investors locked in profits and rotated briefly toward more defensive areas late in the year.

Weakness was spread across several of the Fund's core themes. Areas such as digital entertainment, cybersecurity, biotechnology, clean energy, blockchain and China internet all detracted over the month, while individual holdings including CrowdStrike, MercadoLibre, Nu Holdings and Madrigal Pharmaceuticals also faced short-term pressure. This volatility followed a period of strong performance earlier in the year and was consistent with the Fund's higher-risk profile.

Importantly, the long-term investment case remains intact. The portfolio is deliberately positioned around powerful structural trends, including artificial intelligence, digital infrastructure, cybersecurity, healthcare innovation, electrification, clean energy and advanced semiconductors. These themes continue to benefit from sustained capital investment, accelerating adoption and long growth runways that extend well beyond short-term market cycles.

As we move into 2026, the Fund remains focused on capturing the upside from transformational technologies and innovation-led growth, accepting higher short-term volatility in pursuit of long-term capital appreciation.








## Sector Allocation
