Investment Objective

The objective of the MGTS IDAD Future Wealth Sub-fund is to provide capital growth over any 7 year period.

Investment Manager Commentary

Thematic equities extended their strong run through October as investors embraced the continuation of global rate cuts, fiscal support, and resilient earnings growth from innovation-led sectors. Sentiment stayed upbeat despite elevated valuations, with volatility contained and optimism around AI productivity, digital transformation, and clean-energy transition continuing to drive leadership across growth markets.

The Future Wealth Fund rose around +7.7% over the month, well ahead of the IA Flexible Investment benchmark (+3.5%). Gains were broad-based, led by Digital Industry and New Energy, where Global X Blockchain, VanEck Uranium & Nuclear, and First Trust Semiconductors posted standout double-digit returns. Healthcare innovation also contributed positively through iShares Healthcare Innovation and First Trust Biotech, while modest weakness in Madrigal Pharmaceuticals, China Internet, and gaming names provided only a minor offset.

The fund remains positioned at the intersection of transformative global themes — from AI, robotics, and digital infrastructure to next-generation healthcare and clean energy. These structural forces are not only reshaping economies and industries but increasingly touching every aspect of daily life. With monetary and fiscal conditions turning supportive and innovation momentum accelerating, the long-term investment case remains compelling. The portfolio continues to blend targeted exposure to tomorrow's growth leaders with prudent diversification to capture opportunity while managing near-term volatility.

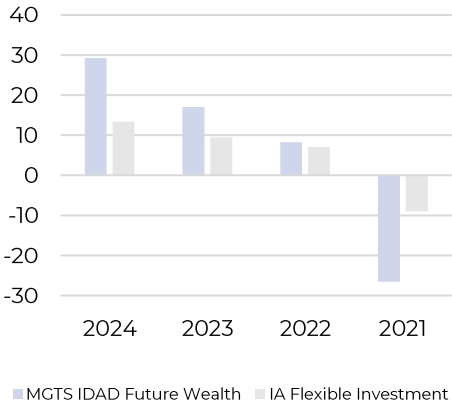

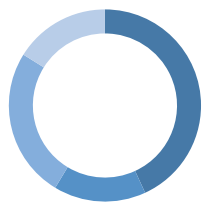

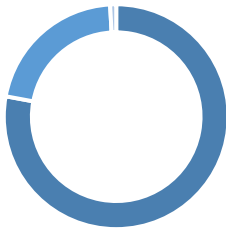
Sector Allocation
